HEREBY ORDERS AS FOLLOWS:

1. The association known as "Living Alternatives for the Ageing", abbreviated « LAFTA » with head office in Bamenda, Mezam Division, is hereby authorized with effect from the date of signature of this Order and in application of the provisions of Section 9 of Law No. 99/014 of 22 December 1999 cited above.
2. The objectives of this Non Governmental organization are to:
 - ensure the multi-dimensional management (sports, physical, health, psychological and psycho affective) of elderly persons in institutions or families;
 - organize activities in the area of tourism, sports, as well as leisure games for elderly persons;
 - build and administer centres reserved for elderly persons;
 - maintain effective relations between elderly persons and their descendants through the promotion of the spirit of solidarity, tolerance and responsibility in the younger, ones;
 - Ensure the rehabilitation of elderly persons within their respective families by instituting a capacity building programme for young members, taking into consideration their cultural environment.
3. The administration of the NGO "Living Alternatives for the Ageing" shall be ensured by its founding President, Mrs Elizabeth MAKWANG MOFOR, P.O Box 519, Nkwen-Bamenda.

4. This order shall be registered, published in the Official Gazette in English and French and notified wherever necessary. /
